Annual Statutory Meeting of the Council

Minutes of the Annual Statutory Meeting held on Monday 15 May 2023 at 7.30pm at Dunkirk Village Hall

1. Acceptance of Office

All councillors present signed the acceptance of office. Agreement was given for Cllr Clifford to sign as soon as possible following the meeting.

2. Election of Chair (and agreement to sign Declaration of Acceptance of Office)

A motion asking for the current Chair to continue in his role was proposed by Cllr Smith, seconded by Cllr Coleman and agreed unanimously.

Cllr Kemp accepted continuing in the position and duly signed the Declaration of Acceptance of Office.

3. Election of Vice Chair

A proposal for Cllr Smith as Vice Chair was made by Cllr Kemp, which was seconded by Cllr Coleman. A proposal for Cllr Tutt was made by Cllr Brice but not seconded. Four councillors then voted in favour of Cllr Smith. Cllr Smith accepted the position.

4. Review any vacant positions arising and co-opting

Greg Hewett a previous councillor explained that he was out of the country at the time for submitting nomination forms for the local election but wished to re-join the council. Cllr Tutt requested to wait a further month to allow for advertising of the vacancy. The Clerk and Chair had taken advice that the local election was in effect the advertisement and there was no requirement to wait. Cllr Smith proposed to co-opt Mr Hewett, seconded by Cllr Brice with 4 in favour and abstention.

Cllr Hewett then signed the acceptance of office.

5. Review of Planning Committee arrangements to be replaced by Extraordinary Meetings

Cllr Kemp and Cllr Smith had submitted a motion request to replace the planning committee with extraordinary meetings. Their reasoning behind this were circulated ahead of the meeting (Appendix 1). Following a discussion the council voted 5 in favour of the motion and one abstain. The motion was passed.
