 The Prime Minister made a statement on 27 January in the House of Commons that outlined the latest updates concerning COVID 19 measures that are now taking place in the UK and specifically in England. You can read his statement here:

Criminals are using the coronavirus vaccine as a way to target the public by tricking them to hand over cash or financial details. They are sending convincing-looking text messages telling people they are eligible for the vaccine or are phoning people directly pretending to be the from the NHS or their local pharmacy. For the foreseeable future, most of us will continue to be working remotely in home settings. This applies to the KALC team but we are always available for you to contact us for your queries, advice and events. Our website is updated very regularly and we will continue to send you relevant national news and guidelines.

This year will be a challenging one, not only because of the Pandemic.

- We saw before the Christmas Holiday that Kent was subject to traffic problems at the Port of Dover and the major road routes that surround it. At the time of writing, this has calmed down, but there is always a risk that member councils will have to deal with similar issues whilst the documentation process post Brexit continues to affect logistics on this side of the Channel.
- The government is not currently planning to extend the remote meeting regulations beyond 7 May 2021. Along with other local government bodies, the National Association of Local Councils (NALC) is continuing to press for this extension. It is also preparing guidance for local councils on preparing for and managing the return to physical meetings in May and beyond.
- Please be aware that the deadline for nominations to the KALC Community Awards is 12 February 2021 - more on this subject can be found on page 3.

## 2021 Community Awards Scheme launched to recognise community champions

On 23 November, the Kent Association of Local Councils (KALC) launched its eighth KALC Community Awards Scheme, inviting nominations for selfless individuals from across the county, who make significant contributions to their communities.

The scheme is supported by the High Sheriff of Kent, Kent County Council and Medway Council.

Nominations are invited from Parish, Town and Community Councils and Parish Meetings (Local Councils) for people living or working within their boundary. The Local Councils make their own decisions about how they want to identify those who have made a significant contribution to the local community and there are no pre-determined criteria for what the contribution to the community might be. The Awards Scheme has proved very successful since it was originally launched in 2013. Among last year's winners were volunteers who had spent many years organising village activities, serving on local community



## COVID 19 UPDATES



Everyone without symptoms should get tested every 2 weeks, especially if you're leaving the house for a necessary reason, such as going to work or shopping for essentials. Around 1 in 3 people with COVID-19 have no symptoms, so get tested regularly to make sure you are not unknowingly spreading the virus.

You can book an appointment at any of the 22 sites across Kent.

These sites are in addition to the regional and local testing sites for people who have symptoms.

Symptom-free testing sites are being set up using funding from central government to support local councils and help reduce rates of COVID-19.



### Unoccupied buildings: top tips from Came & Company

Leaving local council buildings unoccupied may result in increased risks, and can mean that unexpected incidents can potentially do more damage as they are not identified as quickly. We have put together some tips to help you minimise some potential issues.

- Review your risk assessment of the property to identify and minimise potential risks including Covid-19 considerations.
- Water damage can be an issue for unoccupied buildings so consider whether it's appropriate to turn off the water supply at the mains or drain down systems.
- Review your existing fire prevention plan to ensure that fire risk is minimised as much as possible.
- Fire and burglar alarms should be activated and all internal doors should be closed.
- Activate sprinklers and other fire suppression systems you may have in place.
- Non-essential electrical equipment should be unplugged.
- Unoccupied premises may be more at a risk of theft, criminal damage or arson so try and ensure premises are as secure as possible.
- Remove IT equipment or other valuable assets from view if you can, and lock away machinery and tools.
- Avoid leaving vehicles parked next to the property if possible.
- Don't leave any bins or other combustible materials against your property they should be at least 10m from any building and 2m away from any boundary if possible.
- Make sure gates are locked securely to prevent access and reduce the risk of potential fly tipping in the grounds.
- If you are able to inspect the property on a regular basis, then include the perimeter fence and any out-buildings in the inspection.

"The National Association of Local Councils (NALC) is urging the government to push the <u>Non-</u> <u>Domestic Rates (Public</u> <u>Lavatories) Bill 2021-22</u> over the finish line and finally deliver on its 2018 budget pledge.

The bill has its long-awaited second reading in the House of Lords on 18 January after being resurrected last year by the government following pressure from NALC and the All-party parliamentary group on local democracy. Once royal assent for the bill is received, it will finally end the "toilet tax" – business rates local (parish and town) councils have to pay on public conveniences they own or manage – and result in a backdated rebate of these rates since 1 April 2020.

This bill is the latest in a long line of government bills since 2016 which have not completed their journey through parliament. NALC has welcomed this next stage of the Bill but is now pressing the government to prioritise this bill for its remaining stages and finally get it through parliament, after a campaign lasting well over five years.

In a briefing to Peers in advance of next week's debate, NALC has also warned that local councils continue to face financial pressures as a result of COVID funding from the government not reaching local councils. Among the measures, NALC continues to lobby the government on are access for local councils to apply in their own right to central government funding sources, and long term exemption from referendum principles."

## Your Section 137 Figures for 2021/2022

The Ministry of Housing, Communities and Local Government (MHCLG) has notified the National Association of Local Councils (NALC) that the appropriate sum for the purpose of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for parish and town councils in England for 2021-22 is £8.41 per elector.

This is the amount as a result of increasing the amount of £8.32 for 2020-2021 by the percentage increase in the retail index between September 2019 and September 2020, in accordance with Schedule 12B to the 1972 Act.

Cllr Sue Baxter, chairman of NALC, responded: "I welcome this important notification from the government about the increase to the level of section 137 expenditure for local (parish and town) councils. This enables local councils to spend a limited amount of money for purposes for which they have no other specific statutory power, and will help England's 10,000 local councils continue to play their part in responding to the Coronavirus pandemic and supporting their communities." **ONWARD** *The Policies of Belonging*  The National Association of Local Councils (NALC) is supporting the call from the think-tank Onward to give every area a local (parish and town) council to bolster communities and community resilience.

The report, *The Policies of Belonging*, says that when the government publishes the Devolution White Paper it should include a provision for the introduction of local councils in places where they do not currently exist because every area should be given the "right to self-government" through a local council.

The report adds that "ministers should pave the way for the widespread introduction of [local councils], while also giving [local councils] the right to assume ownership of, and responsibility for, green spaces, community sports facilities, community centres and local high street maintenance in their area".

Cllr Sue Baxter, NALC chairman, said: "Levelling up local democracy by creating more local councils everywhere and expanding their role is rightly at the heart of Onwards timely proposals to repair our social fabric.

"Local councils have been the

backbone of the pandemic's response, demonstrating their importance as a growing and changing unit of solidarity and natural focus of community effort in building strong and resilient communities.

"I look forward to working with Onward to take on the proposals in its report and support local councils to continue to be ambitious and help make a change in their area."

Since 2013, a number of measures have been introduced to increase the use of local councils in England, including reducing the number of petition signatures required from 10% to 7.5% and giving community groups the freedom to create local councils as long as a neighbourhood plan is in place. However, only 25% of the population of England is covered by local councils, compared to 70% of Wales and 100% of Scotland.

The National Association of Local Councils (NALC) has been invited to sit on and secretariat the Prime Minister's Champion Group (PMCG) on dementia.


NALC has been invited to sit on the group alongside other key stakeholders, to collaborate on a national scale to create Dementia -Friendly Communities and services. NALC has also agreed to become the secretariat group for 2021.

The PMCG was established by former prime minister David Cameron in 2012 and looks to make the UK the best in the world for dementia care, support, research, and awareness. Given the ongoing impact of COVID-19 for people living with dementia and their families, the work of this group has never been more critical.

NALC's involvement in the PMCG continues a running thread of work on dementia, as in 2020 NALC co-wrote and published a publication on Dementia-Friendly Communities alongside the University of Plymouth. The document aimed to encourage all local councils to support people living with dementia and their families in their communities and is supported, by prime minister Boris Johnson MP.

NALC chairman, Cllr Sue Baxter, said: "Dementia is a cause close to my heart due to the effect that it has on our residents and communities. I am thrilled that NALC has been invited to be involved in the Prime Minister's Champion Group on dementia. Local (parish and town) councils are essential to improving the lives of people in our communities and I am looking forward to seeing the outcomes of the group's work over the coming year."

Co-chairs of the PMCG on dementia, Angela Rippon CBE and Jeremy Hughes CBE said: "It is enormously valuable to have NALC providing the secretariat for the Prime Minister's Champion Group. This is a further demonstration of their commitment to support dementia-friendly communities across the UK."

resurfacing to a Kent-based company, GW Highways. This covers the next two calendar years, with the possibility of extending for a further two years based on performance. The work delivered under this contract will include medium to large scale resurfacing schemes and a number of projects involving full reconstruction of roads, which in turn will reduce potholes on

A thank you and reminder from the Street Lighting Team

Following an extremely busy and successful Festive Lighting season we would like to thank all of you who submitted their applications in good time for the festive switch on.

We thought we would take this opportunity to remind you of the process for Attachments to Street Lighting Furniture on the Highway. You will recall that in the January 2020 KALC newsletter we talked about the different types of attachments we are generally asked about and explained our requirements to enable a smooth and trouble-free application process. Many of you have implemented the load testing which is required, but as we find ourselves nearing the 'in Bloom, 2021' season we thought it would be an opportune time to remind you that your applications should be sent in for your Hanging Baskets as soon as you possibly can so that we can ensure that there is no hold up and that your baskets can be placed on the Street Lighting Assets on the dates you require.

#### First time applications

Should this be your first time in applying for this or any type of permit please contact Sharon Robbins at <u>Sharon.robbins@kent.gov.uk</u> who will be happy to assist you and explain any additional requirements we may these roads for years to come. The first phase of Kent's road resurfacing programme for 2021 delivered by this contract, worth £5 million and including twenty six locations around the county, will be delivered before the end of March.

A considerably larger programme will continue over the spring, summer and autumn months. Combined with our road preservation programme, which extends the life of roads and also prevents potholes, the investment by Kent Highways in planned road maintenance will continue to be a significant increase on past years.

need. Attachments can include festive decorations, hanging baskets, banners, signs, CCTV cameras, ANPR cameras, traffic count equipment etc.

#### Fees

In 2016 fees were introduced for the processing of permits. This recovers the administrative and engineer time taken to review each permit. The fee does not include any load testing that may be required, and this is chargeable to the applicant.

A new permit application or change in assets to be used currently attracts a fee of £102.00. A repeat application using the same assets is charged at £29.00. Fees are reviewed each year and updated rates are published on the KCC website in April. The application form can also be found on the KCC website: - <u>https://</u>

An application is required every year so that we can carry out the checks identified above and verify that assets are still suitable to be used. We try to process every application within 28 working days but are sometimes restricted at certain times of the year, which is why we encourage early application as much as possible.

## News from Kent County Council



"Dear Member & non-Member Councils

On 26 January, Kent County Council launched a consultation on Vision Zero: The Road Safety Strategy for Kent 2020 – 2026 – see <u>https:// kccconsultations.inconsult.uk/consult.ti/</u> <u>visionzero/consultationHome</u>.

The consultation closes at 23:59 on 15 March 2021.

As set out on the KCC website, they are consulting on their <u>draft five year Road Safety</u> <u>Strategy for Kent</u> and their 30 year vision. 'Vision Zero' aims for zero, or as close as possible, fatalities on Kent's roads each year by 2050. To achieve Vision Zero, KCC propose adopting the '**Safe Systems'** approach, which is rooted in the belief that every traffic death reflects a failure in the system, and that none are acceptable.

**Safe Systems** put the human being at its core, accepting that even the most conscientious person may make a mistake at some point. The goal of **Safe Systems** is to ensure that these mistakes do not lead to a crash or, if a crash does occur, it is sufficiently controlled to not cause a death or a life-changing injury. As KCC highlight, the success of this strategy will depend on engagement with Kent's communities to work together towards safer roads, towns and villages.

As part of that early engagement, we have organised 2 FREE virtual workshops with KCC to provide an opportunity for Parish, Town, Community and County Councillors to discuss the detail of the Vision Zero

#### Strategy.

It is also seeking early views and evidence on policy options for the government's future night flight policy at designated airports beyond 2024 and nationally.

## Procurement and subsidy control guidance



The Government has updated guidance for public bodies following the UK's exit from the European

Union. This is required as EU law no longer has any force in the UK except in those areas provided for by the Withdrawal Agreement.

Councils, as with all public bodies, should continue to ensure compliance with all relevant domestic and international law, including World Trade Organisation commitments and commitments the UK has entered into under bilateral Trade Agreements.



Councils should also be aware that obligations arising from domestic and international law are binding for the whole public sector and should assist partner organisations in complying where new obligations have arisen. In particular, the Government has published updated guidance relating to public-sector procurement and subsidy control for public authorities.

## Kent County Council Grants Towards New Websites



Parish Councils who are/were customers of Cantium/EIS and whose precept is under £30,000 could be eligible for a KCC grant towards their new website. Those councils should have received a letter from Kent County Council on 20 November 2020 where KCC explained that they would provide financial support for those councils who had a precept of less than £30k and who were a customer of the Cantium Business Services web platform prior to the legislative change (Web Accessibility Regulations). This support in-

cludes a financial package that covers the website for the first year (up to  $\pm 900$ ) as well as up to  $\pm 300$  towards off-boarding costs associated with moving from the current platform to Aubergine or another website provider. Funding after the first year will then fall to the parish/town council.

We have written to all those councils that we think are eligible – sent on 5 January 2021. However, not everyone has responded. If your council was a customer of Cantium Business Services/ KCC EIS prior to the legislative change and your council has a precept of less than £30,000, then please contact <u>chief.executive@kentalc.gov.uk</u> as soon as possible to see whether your council is eligible for a grant. The deadline for applications is **31 March 2021 at the latest**. Page 23

In Your Neck of the Woods - Updates from Our Parishes and Towns. Support Still Going Strong in Lockdown!

Thank you for all your articles regarding your community efforts in

making #Lockdown that little bit easier on your residents.

We will be doing a "feature article" next month in our

February issue of KALC News that we hope

will bring together some of the new initiatives that you have launched in this second National Lockdown.

In the meantime, we have news of two particular schemes that need mentioning to our readers.

Our members will be aware from our article on page 5, that Kent County Council is now offering "symptom free testing" for the COVID 19 virus. This is not to replace the normal NHS testing that is booked through GOV.UK, but is available to anyone without symptoms to see whether they could be carrying the virus without knowledge. There are many sites that have been set up to do this.

#### One of them is at Swanscombe and Greenhithe Town Council and this is what Graham Blew, the Town Clerk, told us:

"Working with KALC and KCC we managed to ensure that one of the Town Council's facilities was used by KCC as a one of their Asymptomatic

Testing Centres. This obviously has huge benefits not only for the residents of Swanscombe and Greenhithe but also those in the surrounding communities who will now have far less distances to travel.

When we promoted this facility, one

of our entries on Facebook received 12,366 views, 2,033 engagements and 56 shares".

Borough Green Parish Council also wrote to KALC and let us know what they have been up to in their community. Mike

Taylor, Chairman of the Parish Council said:

"We were approached by the Parent Teacher

Association (PTA) at Borough Green Primary School about some disadvantaged pupils who did not have internet access for home schooling, or had to share a single device with siblings.

Two of our Councillors are in IT and sourced a supplu of HP Chromebooks. The Parish Council checked our legal position with Clive, and bought 20 devices, 15 for Borough Green Parish Council and 5 for Borough Green Children at nearby Platt primary school. It struck me that this initiative might be useful to other communities. Primaru schools seem to have fallen short in the Government initiative to get devices out to secondary school pupils, and most Parishes could manage a small donation to their local primary school."

## SUSSEX LUND 2021 GRANTS PROGRAMME NOW OPEN FOR APPLICATIONS

Community groups, trusts, charities, town and parish councils, schools and individuals who own or manage land in the High Weald Area of Outstanding Natural Beauty (AONB) can now submit new applications for funding from the <u>Sussex Lund grants programme</u>.

Following a year that has highlighted the huge importance of our connection with the beautiful landscape on our doorstep – and our responsibility to look after it – the scheme is offering grants of between **£500 and £10,000** for practical projects that improve habitats, wildlife and natural beauty.

Sussex Lund is a collaboration between the High Weald AONB Partnership and Lund Trust, a charitable fund of Lisbet Rausing and Peter Baldwin. Since it was launched in 2016, the annual scheme has awarded over £750,000 to more than 160 projects, including:

- Restoring hazel coppice for dormice and creating glades and rides in woodland
- Replacing and installing new barn owl nesting boxes across a 10km stretch of farmland
- Planting fruit trees and managing orchards in a nature-friendly way
- Creating wildflower-rich grassland to boost the number and diversity of pollinators
- Restoring and creating ponds and other wetland habitats
- Creating new woodland to provide habitat for a farm's breeding nightingale population.

High Weald AONB co-director, Jason Lavender, said: "We're seeing more and more people keen to manage land within the High Weald for nature and scenic beauty, which is fantastic. However, the funding needed for some projects means they can be out of reach, particularly after a tough year. We are delighted to be launching Sussex Lund in 2021 as a wonderful way of helping community groups, land managers and others across the area to recover nature."

Those thinking of applying to Sussex Lund must first discuss their project idea with the High Weald AONB team to ensure it meets all the application criteria – if you haven't already made contact, please call Christine Meadows on 01424 723009 for an informal chat (you may need to leave a voicemail due to current remote working arrangements).
