Applications can be submitted anytime between 1st November 2021 and 31st January 2022 but Councils are encouraged to submit their applications as soon as possible. Only one application is permissible per Council and the application must be approved at a Council Meeting before being submitted. Councils are permitted to apply for projected costs up until 31st March 2022. The funding has been allocated as follows:

- **Parish/Town/Community electorate figure is 500 or greater: Funding amount based on electorate data at £1 per electorate**
- **Parish/Town Council electorate figure is less than 500: Funding amount will be £500 per Parish per Parish/Town Council**

NALC LAUNCHES NEW PUBLICATION ON WEB ACCESSIBILITY

The National Association of Local Councils (NALC) has published a new guide on website accessibility and publishing guidelines.

The guide aims to help local (parish and town) councils ensure their websites meet the needs of all users — especially those with disabilities or impairments that use assistive technology.

The guide explains what website accessibility is, how it affects local councils, the requirements, and compliance. It details what a council must publish under the Transparency Code 2015, the costs of running a website, where to get help, what ongoing checks are needed, and discusses the future of website accessibility. The guide also contains a step-by-step guide and a range of resources.

The guide can also aid those who write and create content for websites and use it as guidance to give to their website designers who may not be aware that local government websites need to comply with the Transparency Code.

Cllr Sue Baxter, NALC chair, said: "One in five people in the UK has a form of long-term illness, impairment or disability. It is critical, NALC continue to produce resources that help England's 10,000 local councils ensure their websites are accessible to everyone in the communities they serve".

NEW PUBLICATION FROM NALC ON CLIMATE CHANGE

NALC has published its new report on what can local councils do on climate change.

The report aimed to paint an accurate picture of how climate change is being tackled by local (parish and town) councils and identify the challenges they face. In doing so, NALC can better understand how to support local councils in creating more sustainable communities.

The research found that 38% of participating councils had already declared a climate emergency and a further 8% were pending declaration. An identifiable trend of the report found that councils who had made such declarations were more likely to take positive action on climate change.

However, local councils overwhelming challenge is that they feel too small to affect change due to a lack of expertise, finance, and power to act. 69% of councils needed guidance to apply for grants and subsidies, and a further 58% reported a need for improved skills and training.

NALC is committed to guiding and supporting local councils in accessing funding, expertise and power to influence to tackle climate change within their communities.

Government consultation on making flexible working the default:

- The consultation seeks views from individuals and businesses on proposals to reform flexible working regulations. The proposals include making the right to request flexible working a day one entitlement, as well as introducing a day one right to one week's unpaid leave for carers. Minimum Wage For 23 Year Olds to Rise...



The Minimum Wage for workers aged 23 years old and above is set to rise from the new financial year in April 2022. That means that the current rate of pay, which is £8.91p an hour, will increase to £9.50p

Younger people under the age of 23 will also see an increase in their minimum rates of pay.

The National Minimum Wage for people aged 21-22 will rise from £8.36 to £9.18 an hour and the Apprentice Rate will increase from £4.30 to £4.81 an hour.

This will be especially of note to our Parishes and Towns who have younger members of staff on their payroll.

Further to the announcement from Buckingham Palace on 2nd June 2021, regarding the Platinum Jubilee Weekend of 2nd - 5th June 2022, which The Queen's Platinum Jubilee Beacons is part of, I have pleasure in confirming the Guide To Taking Part in this event is available to view and download from - www.queensjubileebeacons.com and will be updated on this site at the end of each month as more and more communities, individuals and organisations etc, join the event over the forthcoming months. The beacon lighting and associated activities will take place throughout the United Kingdom, Channel Islands, Isle of Man, UK Overseas Territories and, for the first time, in each of the Capital Cities of all the Commonwealth Countries on **2nd June 2022**.

Pages 11, 12, 13 and 14 show the various types of beacons to be used for this historic occasion that can be lit in farmers' fields, on country estates, on the top of high hills, around our shorelines on cliff tops and on beaches, with gas-fuelled beacons on church towers and castle battlements and permanent beacon braziers made and lit by craftsmen and women in the centre of town and village greens, providing a lasting reminder of this historic moment in the history of The Queen's reign. Those considering purchasing one of the gas-fuelled Beacons found on pages 11 and 12 could consider organising a local raffle with the winner having the honour of lighting the beacon on the night, with the funds raised being donated to a local charity or used to cover the cost of the beacon and the bottle of gas required to fuel it.

Those wanting to take part are being asked to go to page 10 and provide us with the information requested in Step 1, enabling us to include them in the monthly guide updates over the forthcoming months, along with sending them further information in due course. Many of those receiving this communication will already have permanent beacons in place, so please light them for this occasion but remember to still register your involvement as soon as possible please. From pages 16 onwards you will see those, to date, that have already agreed to take part around the UK and the Commonwealth. These lists and pages in the guide will be added to over the forthcoming months as more communities etc, join the project.

From the guide, you will see that we are involving town criers undertaking the Proclamation at **1pm** announcing the lighting of the beacons that evening and pipers playing *Diu Regnare* at **9.09pm**, before the beacons are lit at **9.15pm**.

With this in mind, please consider sourcing a local piper to play this tune at your beacon location before lighting it at **9.15pm**. If this is the case, please register your piper in a similar way to your beacon by no later than end of **May 2022**.

This could well be the last chain of beacons lit during The Queen's reign, so we want to make it the largest and most dramatic the world has ever seen. We do hope therefore, that you will help us achieve this by taking part in lighting a beacon at **9.15pm on 2nd June 2022**.
