KALC urges MPs to press Government to bring forward

legislation on remote meetings

As members will know, the Government decided not to extend the Coronavirus emergency legislation to enable Councils to hold remote Council meetings beyond 6 May. Instead they issued a Call for Evidence on remote meetings which closed on 17 June. Both KALC and NALC responded to the Call for Evidence urging Government to bring forward new legislation to enable Councils to hold remote meetings if they so wish. Disappointingly, we still await the Government's response, despite being pressed by NALC and the LGA.

KALC has just written to Kent MPs asking for their help and support in getting MHCLG to move forward on this urgent matter and bring forward emergency legislation to enable Local Councils at all levels of Local Government to be able to hold Council meetings remotely if they so wish. NALC and other County Associations are doing the same. We would encourage all our member councils to also approach your local MP and ask them to press the Secretary of State for Housing, Communities and Local Government for a response on this important issue.

KALC 2021 AGM being held virtually on Saturday 13th November 2021



NALC HOLDS ITS FIRST YOUNG COUNCILLORS NATIONAL NETWORK MEETING

The National Association of Local Councils recently held its first National Network meeting dedicated to Young Councillors.

The network discussed getting young people involved in their community, working with and learning from more experienced councillors, ways for the network to stay in touch, and developing skills and knowledge.

Cllr Sue Baxter, NALC char, said: "I was delighted to host NALC's latest new national network, especially as getting younger people involved in our communities and local (parish and town) councils is important to ensure we are more representative of the communities we serve and young people can influence the decisions that affect them. It was great to hear from all the young councillors about their experiences including those who turned eighteen over the last year and were elected in May 2021. The network will provide an invaluable opportunity to connect young councillors to discuss issues

of common interest and provide mutual support, and I'm keen for more young councillors to get involved".

The new network is one of several NALC has established including coastal communities, LGBT+ councillors and women councillors, and aim to connect councils and councillors from across the country, learn from and support each other and share good practice.

Share of £30m Changing Places toilets fund now open for applications

Councils are being urged to apply for a share of a £30 million fund to install life-enhancing Changing Places toilets (CPTs) in public places and tourist attractions, providing a significant increase in areas where users want them most.

There are currently around 1,200 registered Changing Places toilets in England – these are larger accessible toilets for people who cannot use standard accessible toilets, with equipment such as hoists, curtains, adult-sized changing benches, and space for carers.

Councils will be invited to complete a short expression of interest to receive a proportion of this funding. They are encouraged to consider where Changing Places toilets are most needed in their communities and are encouraged to work in partnership with other organisations to deliver these facilities, including securing match funding wherever possible.

NALC urges ministers and MPs to involve communities more in planning

The National Association of Local Councils (NALC) has written to the planning minister Rt Hon Christopher Pincher MP and to all MPs urging them to let the voice of local (parish and town) councils be listened to in the planning process and for local councils to be trusted with more powers.

The letter to MPs reiterated NALC's main arguments from its responses to the three main Planning White paper consultations last summer, Changes to the Current Planning System and Transparency and Competition. The main points made were to involve local councils and communities more in decision making around planning applications, to factor the climate emergency into plan-making, to protect the country's green belt and that developers should be required to complete homes for which they have already received planning permission.

The letter to the planning minister highlighted what a Nearly Perfect Planning Future (NPPF) would look like for local councils after the passage of any planning bill through parliament. NALC clearly and positively painted for the minister a future which puts local councils at the heart of a planning system based on greater democracy and less centralisation.

Completion of Kent's Road Surface Dressing Programme



Kent County Council has successfully completed a £2.1 million road surface preservation programme to extend the life of 45

miles (71 kilometres) of Kent's roads. This specialist treatment called *surface dressing* preserves the structure of roads and extends their useable life. Roads preserved include major strategic routes such as the A228 Ashton Way, Seven Mile Lane and A25 Maidstone Road. The works were completed over a three week programme in July/August and saw 47 roads treated.

Surface Dressing is the application of bitumen, which is sprayed onto the road surface followed by the laying of chippings. Sometimes multiple



layers of bitumen and/or chippings are laid. These layers seal the surface to prevent water penetration, restore texture and improve skid resistance. It is a quick and efficient process that brings real benefits to Kent road users and taxpayers by extending the lifecycle of the road asset in the most economical fashion. The cost of this treatment is £5 per square metre which can preserve a treated road for up to ten years and extends the time before more disruptive and extensive renewal works are required. This compares very favourably to traditional resurfacing methods which can range between £25-30 per square metre.

Community Mental Health and Wellbeing Services at Kent County Council : A Consultation

Kent County Council (KCC) has launched a consultation regarding the future of its provision of Community Mental Health and Wellbeing Services.

The Consultation opened on 23 August and closes on 3 October 2021.

When we talk about these services, these are:

- Live Well Kent and Medway
- Mental Health Housing Related Support (Kent only)
- 24-7 Telephone and Online Support Service for Kent and Medway (Release the Pressure helpline)
- Activity Programme for Young People aged between 14 – 35 who have suffered from a first episode of psychosis (Kent only)

Services are currently delivered across Kent and Medway by a wide range of local charities and organisations. KCC and K&M CCG directly contract with two providers, known as Strategic Partners, who both deliver services directly and subcontract to a wide-ranging Delivery Network of providers.


The contracts with the two Strategic Partners come to end on 31 March 2023. Therefore, in preparation for the start of the new contract, KCC and K&M CCG wants to ensure services deliver the personal outcomes which are most important to Kent and Medway residents.

Update from Kent Downs AONB



The 3-year scheme aims to fund outcomes for People, Place, Climate and Nature in the Kent Downs. It is possible to apply for more than one year. Applications can range from an absolute maximum of £250K for very exceptional projects with no minimum (these limits will be reviewed by the appraisal panel). Funding can be up to 100% but value for money is part of the assessment criteria; grant rates will be lower where there is a profit element to the project proposal.

Through the programme, farmers and land managers in the Kent Downs AONB* will be supported to carry out projects that:

- Provide opportunities for people to discover, enjoy and understand the landscape and cultural heritage
- Support nature-friendly, sustainable farm businesses
- Mitigate the impacts of climate change
- Support nature recovery

Introductory information is available on our website along with Kent Downs indicative project ideas.

Applications to the programme will be judged by an independent assessment panel and the Kent Downs AONB Unit will provide one-on-one support during the application process.

We welcome enquiries and so please complete our brief <u>Contact Us</u> form to discuss the programme and ideas that you might already have; we will get back to you as soon as we can.

*Use our <u>Boundary Map</u> to check if your land is in within the AONB boundary, if it isn't but your idea could be of benefit to the Kent Downs AONB, you may still be eligible.

A Pandemic Success in Great Chart and Singleton!



Great Chart and Singleton Parish Council took over the lease of the Singleton Environment Centre back in March 2018. Keen to make the property work as a community space, an extension was needed - this is their story and is definitely a Pandemic Success!

At the end of 2019, the Parish Council started the process and obtained Planning permission for the two story container building, the design of which had evolved over several months and with more than a few conversations and improvements to it. Permission was sought from the Landlord (Ashford Borough Council) this was obtained.

Costplan, the management agent, was engaged to oversee the project form tendering to completion. The Tenders went out during February 2020, the contractor to be chosen during April and May and a planned start date in June/July. The Council had a completion date of 23 October – but none of these timings allowed for the devastation caused by a global pandemic. However, the Council

proceeded and hoped for the best as a pandemic was new to all and the effect could not be predicted. The process had to be dealt with as everyone else was doing: one day at a time.

After the first total lockdown, the Council eagerly waited for work to start, the footings and groundwork started on time, but there was a delay, because of an oak tree and footing depth – this was solved but despite a good summer, not much could be done with the project. The explanation being that materials were slowly being sourced, but delayed because of Covid. This went on for some three months but the Council did what it could.







The work resumed, but the Council was hampered by work being alternated with other much bigger projects at the time, but patience prevailed by all of those involved.

The work did resume but the weather then changed and there was a lot of rainfall which brought its own problems. The finish date of 23rd October came and went and the Penalty Clause of £250 a week was invoked. This worked in the

Council's favour, as during the build out there were various issues needing to be solved that added a cost to the project, some of which could be off set by the penalty clause.

A Pandemic Success in Great Chart and Singleton!

Obviously, time progressed and Kent went through draconian restrictions ranging from Tier 3 Lockdown measures, Tier 4 then finally into another national Lockdown during the winter. This meant more delays took place. However, some work was achieved over the festive period when traditionally the construction industry would shut down for the fortnight over Christmas and New Year.

During January those involved were able to access the inside of the building. The lower level had much more space available for use and the viewing veranda on the container roofs was brilliant. It was certainly much better than had first been imagined. The whole project will make a welcome addition to the Centre! The Manager was very pleased with the size of his new office as he could now see how much of an improvement it was after three years of working in a such a small area.

Bookings began during the Spring of this year and the Centre is now a place of community cohesion, just as the Parish Council had hoped it would be at the beginning of the planning process.
