# Minutes of meeting held at Dunkirk Village Hall on 21 March 2016

# 3. Winterbourne Wood Quarry

Matthew Garvey, of DHA Planning, and a group of parishioners attended the start of the meeting to discuss the housing application for the quarry. Mr Garvey said the site has permission for a large manor house (16,500 sq ft), but hasn't been able to attract developer interest. Therefore, a new planning application for four large homes instead has been submitted (total 10,500 sq ft). The application includes cessation of quarrying and the woodland managed in perpetuity. Concerns from residents included, additional traffic on narrow / subsiding roads; flooding risk as drainage is bad in the area; additional housing development; threat of quarrying if application isn't approved; water pressure problems. Councillors were due to discuss the application later in the main meeting.

One parishioner stayed for the remainder of the meeting.

# 4. Minutes of the previous meeting

The minutes of the meeting held on 15.2.16 and the Planning Committee on 7.3.16 had been previously circulated and were signed as an accurate record.

## 5. Matters arising from the previous minutes

- (a) Courtenay Road Football Field: A reply was received from the Trustees regarding a lease term to use the field for recreational purposed which they did not want to do. However, they would consider supplying a strip of land to the side of the track which leads to the parish council field at the rear. It was agreed to pursue this option rather than the right of way access via Radar Farm.
- (b) Proposed yellow lines opposite Woodmans Hall: Swale's Joint Transportation Board agreed to support the proposal for the yellow lines, subject to amendment following comments by KCC. SBC Cabinet is due to endorse the recommendation at their meeting on 25 May. Once formal notification is received, we (+ Boughton Parish Council) will need to agree the revised proposals, as both parish councils are funding the cost.
- (c) <u>Staplestreet Road signage</u>: Not suitable for HGVs sign have been put up both ends of the road. Other entrances need to be checked for these signs and neighbouring parish councils contacted if necessary.

#### 6. Matters for public concern

#### (a) Highways Issues

<u>Dawes Road</u>: KCC Highways has agreed a site meeting with parish councillors to observe and discuss the road's recent repairs as they don't appear to have been completed to a satisfactory standard. Date tbc.

<u>Jezzards Lane</u>: Some 42 pot holes have been counted along this road. Steve Hitch has reported some and Jeff Tutt suggested all should be reported as separate incidents to raise awareness of the holes for repair. There was also concern for the road as a lot more cars are using it for access to the stables – an unofficial layby has been created when vehicles should be using the off the road and parked on a hard standing at Scoggers Lane.

<u>A2:</u> JT reported some of the pot holes missed by recent road repairs had been fixed, although some still needed attention.

#### Footways and Verges:

Because spring has started earlier, JP expressed his concern for the early birds and suggested residents with problem hedges such as Dunkirk Road North and Worcesters be contacted to ask if they could cut hedges now before the birds nest.

It was noted that a letter in the local press had complimented Swale Borough Council rubbish collectors for clearing up the verges from Brenley Corner to Canterbury.

#### (b) Enforcement Cases

A letter had been received from Swale Borough Council's James Freeman regarding outstanding cases which the parish council has repeatedly raised over some period of time. However, many of the issues had not been addressed with some inspections completely inaccurate and claims made that no complaint had been made when the parish council has a clear record. It was agreed that SBC need to be pressed to respond in detail to each case until they come to a satisfactory conclusion.

### (c) Crime Update

The crime update for January (taken from the www.police.uk website) was tabled and noted. The latest PCSO for the village has moved on and details of the replacement are pending.

On crime matters, it was noted that following the removal of road work bollards at Gate Services, lorries parking illegally on pavements etc, had returned. An email from a Canterbury Road resident described how they were being kept awake at night, particularly from the noise of the freezer lorries. The email was passed to the police who can issues on the spot fines. A special Swale team has been set up to do this.

## 7. Planning

#### (a) Receive Decisions:

16/500288/FULL: Aylesbury Cottage 41a Horselees Road – Conversion of existing integral garage to dining room. Approved.

#### (b) Consider Applications:

16/501552/FULL: Winterbourne Wood Quarry – Revocation of quarrying use and erection of four detached dwellings with garages, associated landscaping, enlarged lake and use of existing access. Councillors voted to oppose the application on the grounds of over development, highways / traffic / access issues, poor design, sustainability, drainage and flood risk issues.

#### 8. Finance

(a) <u>Finance Report</u>: The report and monthly cash account had previously been circulated and were taken as read.
