2. Berkeley House, Boughton Hill (Planning Ref: 19/503137/FULL)

Applicant was due to attend however, following sight of objections submitted by Dunkirk Parish Council (DPC), prior to the meeting, sent his apologies. He requires further time to review the objections with his agent.

4. Minutes of the previous meeting and matters arising

The minutes of the meeting held on 22.7.19 and the planning meeting held on 5.8.19 were both agreed and signed as accurate records.

Matters arising from previous meeting

- (a) <u>Draft Car Parking Supplementary Planning Document</u> The Neighbourhood Plan Committee has been consulted and they will submit recommendations to Swale Borough Council (SBC) for both Boughton and Dunkirk.
- (b) <u>Additional planting in hedge row on London Road</u> Cllr Brice confirmed this will take place once full hedge cutting by SBC has been completed.
- (c) Dog waste bin at Bossenden Woods Not yet in place. Chair to follow up with SBC.
- (d) <u>Jezzards Lane Drains</u> Still blocked. Chair to follow-up with KCC Highways.
- (e) <u>Courtenay Road misleading road sign</u> Has now been removed by KCC Highways. Discharge.
- (f) Footpath beyond Red Lion Park Has been repaired by KCC Highways but there is a hole to one side. Chair to follow-up with KCC Highways.
- (g) <u>Goddens Corner</u> SBC Enforcement was due to undertake site visit (note newly installed gated entrance). Chair to follow up with SBC Enforcement.
- (h) Hedging and trees to be cut back Chair to liaise with KCC and Andrew Bowles to establish dates of when this would be done (post nesting season) and request litter picking to be completed in advance to prevent waste materials being shredded.
- (i) <u>Footpath ZR533 blocked ditches</u> Chair contacted PROW Officer post last meeting. Update to be obtained by Chair.
- (j) <u>London Road Hedge and grass verge maintenance required (before Faversham bound</u> bus stop) Update required.

- (k) <u>Damaged safety railings on Boughton Hill (Lower upward section)</u>: Job logged with KCC Highways but low priority given current need. Ongoing.
- (I) <u>TPO 2 of 2019 Boughton Hill (Jays Wood)</u> Chair to follow up with SBC Tree Officer, Paul Hegley, re: site visit with local residents that did not happen.
- (m) Felling of trees at Dawes Wood Chair to follow up with the SBC Tree Officer re complaints lodged with Forestry Commission around quality of felling and debris.
- (n) Courtenay Road/London Road Streetlight This has now been reconnected. Discharge.
- (o) <u>LED Certificates for upgraded streetlights</u> Still outstanding from UK Power. Clerk to follow up.
- (p) <u>'Thieves operate here' signs for Gate Services</u> Chair is continuing to liaise with PS Jason Hedges and Highways England.
- (q) <u>Brotherhood Wood Meeting with James Freeman</u>. Cllr Gould reported no further information/comments available from James Freeman post their meeting.
- (r) <u>Unused Post Box stand at Horselees Road end of Boughton Hill</u> This has been removed. Discharge.
- (s) <u>Misleading signage for Esso Gate Services on London-bound A2</u> Previously reported to Gary Gibbs. Awaiting further information/decision from Highways or KCC. Ongoing.
- (t) MP Helen Whately Letters to Highways England re continuing ownership and maintenance disputes for Brenley Corner roundabout. Also written to SBC Planning with reference to poor responses from SBC around Brotherhood Wood issues including toileting. Chair to follow up.
- (u) <u>DPC Councillor Numbers</u> Update required at next meeting re: current Councillor Vacancy/application process.

5. Matters for public concern

(a) Highways Issues

Jezzards Lane to Scoggers Hill is closed for a week. The potholes are increasing and are dangerous but whilst the work is continuing it was agreed there was little to be gained by chasing repairs at this point. Ongoing.

Hedges at Goddens Corner, on both sides, need to be cut back as they are causing obstruction to sight lines. Chair to contact owner and request post nesting season hedge cutting.

(b) Footpaths, Verges & Hedges

Notice of Temporary Closure to Footpath ZR536 at Christchurch House received. Effective from 2.9.19 for a maximum of six months in order that works can be carried out on or near it.

(c) TPOs

Notice received that TPO 1 of 2019 (Bossenden Wood/ North Bishopden Wood) confirmed with no objections. Awaiting decisions on five outstanding planning applications for TPO status.

(d) Streetlights: Currently no reports of failed lights.

14. Matters not on the Agenda

<u>Approach to playing field -</u> Vice Chair to be asked to follow up with the landowners to reinstate fence.

Monies from cakes sold post War Memorial Event – All agreed the £10.00 raised should be donated to the Village Hall Fund via their Committee.

Local Transport issues: Two members of the public voiced their concerns and frustrations around the continuing traffic and lorry issues in Dunkirk and surrounding parishes and the multiple associated problems around safety eg, the village becomes gridlocked thus no access for emergency vehicles let alone villagers, human waste left by lorry drivers etc. Cllrs assured the attendees that DPC is continually communicating with many local and county organisations (KCC, Highways England, Kent Police, Swale Borough Council), as well as the local MP, to try to reach a solution. The attendees stressed that the lack or responsibility and therefore the lack of action by these bodies is unacceptable. DPC is limited in the action it is able to take but the Chair is pushing for a meeting to discuss these issues with as many of the relevant people and bodies but in the meantime asked that any parishioners with similar concerns to write to the local MP, Helen Whatley to request action.
