- 5. Highways Issues:
 - a. Ongoing Traffic Issues in Dunkirk and Boughton

JT had meetings and sent emails to highways regarding traffic diversions through the village. The council has been working with Boughton PC and it was decided to add weight to the PCs arguments to start a petition for Dunkirk residents to sign Alistair has informed the Joint Transport Board that this is happening The petition was circulated to council members to sign

b. Footpaths, Verges & Hedges

DB met with Maria McCloughlin (MC) to discuss the footpath from Berkeley Close to Horselees Rd. MC asked when the bollards at the end of the path had been put in place. She needs to investigate the full history of use. There may be some information previously collected from residents that DPC can pass on.

c. Streetlights

JC is liaising with UK Power Networks to get paperwork so that EDF energy bill can be reduced following upgrade to LED streetlights

d. TPO's

TPOs have been removed from land at the rear of properties in Berkeley Close as this has been incorporated into gardens

6. Planning

Receive decisions

New Bungalow Approved 33 Stoney Road Approved

DPC had objected to New Bungalow planning application and JT pointed out that due to a last minute change of date for the SBC planning committee no one from DPC had been able to attend to speak against the application which was regrettable.

JT explained that 18 previous conditions had been ignored and that DPC is unable to do much more. JT will writer to SBC to express our concerns and suggested the neighbours should contact the ombudsman.

Consider applications

19/504879/FULL Demolition of existing conservatory and erection of 1no. new rear conservatory. St Ethelburga 1 Staplestreet Road Boughton Under Blean Faversham Kent ME13 9TJ

DPC voted unanimously to support this application as it is a visual amenity which will presumably be more modern that the existing structure

19/504886/FULL Conversion of garage into habitable space.

Demolition of existing conservatory and erection of single storey side and rear extension.

41 Berkeley Close Dunkirk Faversham Kent ME13 9TR

While in principle DPC is opposed to conversion of garages, due to the location of this house and the available off street parking the council voted unanimously to register no objection to this plan
