

Road Maintenance in Your Area

Vegetation/Tree Removal

When we plan to carry out the work and how long it will take

This is to let you know that, as part of the on-going maintenance and improvement of the highway network, Kent County Council will be carrying out the removal of vegetation and trees on **Canterbury Road, Dunkirk between the junction Stonestreet Road and the stepped public footpath access to Stoney Road.**

These vegetation/tree removal works are programmed to start on the **25/10/2021** and should take **5 days** to complete. These activities will be undertaken between the hours of **08:00 and 17:00** each day.

During these essential works it will be necessary to close the road completely so that we can carry out the works safely for both the workforce and road users. The diversions will be via

Eastbound – The Street, Stockers Hill, Canterbury Road, A2 Boughton Bypass westbound, A2 Boughton Bypass Eastbound, London Road (Upper Harbledown), Upper Harbledown slip, A2 Dover Road (westbound), Dunkirk Slip Westbound and Canterbury Road.

Westbound – Canterbury Road, A2 Boughton Bypass (Eastbound), London Road (Upper Harbledown), Upper Harbledown slip, A2 Dover Road (Westbound), A2 Boughton Bypass (Westbound), A2 Boughton Bypass (Eastbound) and Canterbury Road.

What we plan to do

Kent County Council will be undertaking the removal of trees and vegetation on the northern side of Canterbury Road, Dunkirk. These works are to facilitate bank stabilisation works (sheet piling) and reconstruction of both carriageway and footway to remove the undulations within the current surface.

How you can help us

It is inevitable that residents and businesses near the works will experience some disruption and we apologise in advance for any inconvenience caused, but we will try to keep this to a minimum. Restricted Access to residential properties and all businesses up to the closure point, will be available, but if you have any access needs, please let the workforce on site know.

We need your help to make sure the work is done as quickly as possible and to the best possible quality. **If your vehicle is usually parked on the carriageway, please make sure you park it somewhere else away from the site whilst the works are carried out, so the road is clear for us to resurface.**

For your safety and the safety of our workforce, please drive carefully and slowly through the roadworks.
